<p>ARTICLE 3: Membership</p> <p>1) The members of the Association are the applicants for incorporation of the Association, and those clubs/individuals who subsequently become members, in accordance with these Bylaws and, in either case, have not ceased to be members in good standing.</p> <p>2) Every member must uphold the Constitution and comply with these Bylaws.</p> <p>3) There are three (3) classes of Membership (Club, Voting and Life)</p> <p>4) South Fraser District Association with affiliated youth clubs shall adopt, by December 31, 2023, a clause in it's bylaws or regulations that it's youth clubs must comply with the principles of the</p>

<p>"ARTICLE 3 Voting Membership</p> <p>VOTING MEMBERSHIP</p> <p>Provided that:</p> <p>a. persons that are in good standing and registered as a Voting member in the records of the Society as of March 31 in the year of an Annual General Meeting of the Society for the purposes of voting at that Annual General Meeting of the Society; or</p> <p>b. a person that is in good standing and registered as a Voting member in the records of the Society on the day that is ninety days prior to a Special General Meeting of the Society; and</p> <p>c. the person is not disqualified nor has the person been expelled as a member;</p> <p>the following persons shall be Voting members of the Society:</p>

<p>This amendment is proposed after review by legal professional on constitution and Bylaws to formalize the policy to align the voting members to bring in line with Fiscal Year of the district.</p>			
Per SFDA Bylaws :			
<p>Article 8 Procedure for Amendment. Proposed amendments to the Constitution or bylaws will only be considered if submitted, in writing, to the Society the Board, or submitted by a member to the Association.. Notice of mention of the proposed amendments must be received by the Society at least 21 days prior to any meeting of the members. All voting Members entitled to vote shall be notified of the proposed Bylaw amendments. All Voting Members entitled to vote shall be notified of the proposed Bylaws amendments referred to in subparagraph (20). Such notification shall be made a minimum of fourteen (14) days prior to the meeting called for that purpose..</p>
